



Club Membership Agreement

- 1.** Membership type will determine what facilities and services are offered to you.
- 2.** Use of The Swan Leisure Club premises is strictly in adherence to the rules & regulations in effect at any time.
- 3.** Payment upfront entitles the user to use The Swan Leisure Club for the period paid & must cease once end date is reached.
- 4.** Direct debit memberships must be paid monthly, not go into arrears and must end when end date is reached. These payments can only be made by credit/debit card, no cash accepted.
- 5.** Direct debit memberships will be cancelled if monthly fee is not paid on time. Club Management reserve the right to cancel where these terms are not met by the other party.
- 6.** Membership terms are agreed upon on joining, a 3,6 or 12 month contract are the common types unless otherwise stated and approved by Club Management.
- 7.** Memberships can only commence upon receipt of full or part payment.
- 8.** Any outstanding membership fees from prior transactions must be cleared before a new contract can commence. Club Management have the right to refuse a new contract until outstanding balance is cleared.
- 9.** Membership to The Swan Leisure Club may be suspended or terminated by Club Management for any violation of the rules & regulations of the club, or for any conduct that is deemed to be detrimental to the welfare, good order & character of The Swan Leisure Club and its members.
- 10.** Membership to The Swan Leisure Club is not assignable to other persons other than the named individual on the application. All rights are reserved regarding any refunds, cancellation of membership or auxiliary events which may lead to a cancellation of membership being requested. A membership transfer may be agreed upon request to the Club Manager in writing.
- 11.** Upon commencing membership, you agree that The Swan Leisure Club will not be held responsible or be liable for any loss or damage to any items or personal belongings while on the premises.
- 12.** The member acknowledges that they are using The Swan Leisure Club at their own risk.
- 13.** The member must inform The Swan Leisure Club of any ill health/illnesses/disease or conditions which may impact on their overall health. This will be kept confidential.
- 14.** The Club Management reserve the right to host functions, classes, events & parties at any time without notice.
- 15.** The Club Management will use its best endeavours to maintain all facilities apparatus and equipment are maintained in working order however The Swan Leisure Club accepts no responsibility in any breakdown of equipment however caused.
- 16.** In the event of any dispute arising between a member of The Swan Leisure Club and any staff member or Management Team, the decision of the Club Manager's is final.
- 17.** The Club Management reserves the right to amend any terms & conditions or rules & regulations as they see fit at any time.
